

## **INFORMATION ON THE PROCESSING OF PERSONAL DATA**

This page describes how to manage the site CANDIANI DENIM SPA in relation to the processing of personal data of users who consult it.

This notice is given pursuant to art. 13 of legislative decree n. 196/2003 - Code concerning the protection of personal data to those who interact with web services accessible on the internet at the address:

The following information applies only to the website of the Company CANDIANI DENIM SPA and not to other websites that may be accessed through links to external addresses.

This statement is prompted by Recommendation no. 2/2001 that the European authorities for the protection of personal data, gathered by the Group established by article 29 of Directive no. 95/46 / EC, adopted on May 17, 2001 to identify some minimum requirements for collecting personal data on-line and, in particular, the manner, timing and nature of the information that data controllers must provide to users when they connect to web pages, regardless of the purpose of the link.

### **THE "OWNER" OF THE TREATMENT**

### **PLACE OF DATA PROCESSING, RESPONSIBLE AND IN CHARGE OF TREATMENT**

The processing of the data related to the access of this site takes place at the aforementioned registered office di Candiani Denim spa and is maintained by technical staff in charge of the treatment and, where appropriate, by persons in charge for occasional maintenance operations.

Responsible for processing the data is SYROOP SRL in the person of Federico Cagniney (Project Director).

No data deriving from the web service is communicated or disseminated.

The personal data provided by users who request dispatch of informative material is used only to perform the service or provision requested.

## **TYPES OF DATA PROCESSED**

### *Navigation data*

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the communication protocols of the Internet.

This information is not collected to be associated to identified individuals, but which could, by their very nature, through processing and association with data held by third parties, allow users to be identified.

This category of data includes IP addresses or domain names of computers used by users to access the site, the URI (Uniform Resource Identifier) of requested resources, time of request, the method used to submit the request the server, the dimension of the file obtained in reply, the numerical code indicating the status of the reply given by the server (successful, error, etc..) and other parameters regarding the operating system and computer environment.

These data are used only to obtain anonymous statistics on site usage and to check its correct functioning and is deleted immediately after processing (or are kept in compliance with the terms of the Act). The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site: except for this possibility, at present data concerning web contacts do not persist for more than seven days.

### *Data provided voluntarily by*

The sending of electronic mail to the addresses indicated on this website entails the subsequent acquisition of the sender, necessary to respond to requests, and of any other personal data included in the message.

Specific summary information will be progressively reported or displayed on web pages dedicated to particular services on request.

### *cookies*

No personal data concerning users are acquired by the website.

We do not use cookies to transmit information of a personal nature, nor are used SO-CALLED persistent cookies of any kind, or systems for tracking users.

The use of SO-CALLED Session cookies (which are not stored permanently on the user's computer and disappear when the browser is closed) is strictly limited to transmitting session identifiers (consisting of random numbers generated by the server) necessary to consent the secure and efficient website exploration.

THE SO-CALLED Session cookies used in this website avoid using other computer techniques that are potentially detrimental to the confidentiality of users' browsing and do not allow acquisition of personal identification data.

### **OPTIONAL NATURE OF PROVIDING DATA**

Apart from that specified for navigation data, the user is free to provide personal data through the site.

Failure to provide information could result in the inability to fulfill your request.

### **RULES 'OF TREATMENT**

Personal data are processed by automated tools for the time strictly necessary to achieve the purposes for which they were collected.
